### **Business Session**

- B1. Business Manager Financial Report -
- 1. Approve final 2014/2015 budget- Budget was approved at the meeting on August 11, 2014. The Board had some questions for Liv. The budget has a projected enrollment of 214 and it was asked how firm that number is. Liv expects that it will be a bit lower and will have a firm number with the October count. But for the September meeting, she will let the Board know what each class looks like and bring a more likely number for budgeting. Purchasing new windows throughout the school was discussed. This project is not specifically pointed out in the budget, but it is very high on the list for this year. We do have a projected surplus in the budget and will discuss whether to use that money or hold onto it at the next Board meeting when we have a more firm enrollment number.

## B2. Director Update - Liv

1. Review written admin report - questions and/or important points- The Board had some questions/comments on results of the Parent survey. The survey showed the school needs more frequent and consistent communication from teachers to parents, we need to strengthen the core Waldorf methods and experience in each classroom, and we need to keep better tabs on each class environment - behavioral, progress, etc. Also, Liv needs to ensure she is keeping up with emails and responses. The Board also discussed comments that many parents aren't able to come to parent nights because of

child care. There needs to be more consistent communication with families to encourage engagement. It was also discussed that Parent Council's focus is community building and festival help.

Liv updated the Board on the SAC meeting in which the Parent Survey results were discussed. The Committee would like to develop a response to the results, letting the parent body know what the Administration heard from their responses and the resulting approach. The SAC will meet again to follow up on that in the near future. They also looked at basic results for TCAP, but Liv is not sure yet what role the SAC will play in that.

The Internet connectivity/bandwidth problem has been ongoing, but Liv discussed the options and will be making changes soon.

The Safety document is a work in progress. Liv will hold a Safety Training on Tuesday with the Faculty.

Liv updated the Board on the TCAP results: there is a lot of work to be done. Liv will meet with PSD on Wednesday and will have a better idea where we stand at that time.

# B3. Governance - Hillary

1. Review calendar - August - Hillary's focus has been on the Sustainability Summit and she wasn't able to get back with these items. The Board decided to move these agenda items to the September meeting.

Set Date for October Mid-Year Board Retreat - All (and see note below\*): The Retreat will be held on October 19, 2014 from 8am-12pm. We will set the agenda at the September meeting. It was discussed that we would add the Foundation to the Agenda for the mid-year retreat and have Jessi and Ben attend. The Board will discuss some Board composition review and self evaluation at the September meeting. There was also a discussion on needing more board members, and a decision will be made at the September meeting. The process of getting new board members is not in the bylaws and we may need to amend them to document our process.

Nancy will not be available to attend the mid-year retreat due to the surgery.

2. Strategic Plan and Goals Discussion - Amy and Hillary - This discussion will be moved to the September Board meeting. Strategic Planning needs to be visited at least quarterly. We should leave a half hour or so at the September meeting for some brainstorming activity.

Nancy suggested we move the November meeting to the 3rd so that we can meet with George Hoeffecker. We need to decide what we want to get out of a meeting with George and what his focus will be while he is at the school.

The Board discussed with Jessi that she would like to focus on the foundation and not attend Board meetings unless there is a specific Foundation discussion. She can send updates for the meetings. As an official announcement:

Jessi will continue to attend Board meetings for the remainder of the year (2014) and will step back beginning in January to focus on the Foundation.
